# Help with completing your CREST form

This is a guide to help you complete a CREST transfer form in order to complete the sale of your shares.

Insert the name of the company as it appears on your share certificate

This can usually be found at the top of your share certificate. It normally starts with 'I0' or 'I1' and is 11 digits long.



Write in the type of security, for example 10p Ordinary Shares (this should be shown on the certificate).

This is 10 characters long and the first two characters are 'EQ'.

Write the amount of shares you have sold.

Give the name and address of the owner(s) known to the register (this should be shown on the certificate)

All owners need to sign this form
